Jim Carucci read the Treasurer's Report for the month of August. Cameron McConahy made a motion to accept the Treasurer's Report. The motion was seconded by Alesha Culp and passed with all present voting yes.

Clark Eberhart asked if the Slemmers' / new owners or Lakeside acres were given permission to mow the brush/trees on the ACOE property when they tapped into the sewer lines. He'd like them not to for security of the pump station.

Clark Eberhart read the Sewer bills for the month of September. Clark Eberhart made a motion to pay sewer bills as read. The motion was seconded by Jim Carucci and passed with all present voting yes.

Clark Eberhart requested that council think about finding someone that is certified for the sewers. Joe Simko asked if it had to be the same person that reads the pumps and works on the pumps.

Cameron McConahy read the Fire Report for the month of August. Cameron McConahy made a motion to accept the Fire report as read. The motion was seconded by Clark Eberhart and passed with all present voting yes.

Maryjo Harakal commented on the CVFD equipment in the parade and that many spectators were impressed with their presence.

Larry McKnight stated that the sealcoating project has been completed.

Maryjo Harakal read the letter of request to transfer funds from the liquid fuels savings to checking to cover the sealcoating project and monthly bills.

Maryjo Harakal read the Police Report for the month of July. Cameron McConahy made a motion to accept the report as read. The motion was seconded by Jim Carucci and passed with all present voting yes.

Cameron McConahy stated that he attended the turkey shoot and witnessed a red golf cart with red flames and a yellow 4-wheeler. They have been sited. Cameron advised that from a public safety standpoint, if anyone sees them to ask what they're doing and be aware that they are bad news.


