Minutes of the Clark Borough meeting -November 1, 2022 6:00PM

Cameron McConahy made a motion to accept October minutes as written. This motion was seconded by Doug Robbins and passed with all present voting yes.

Jim Carucci read the Treasurer's Report for the month of October. Jim Carucci made a motion to accept the Treasurer's Report. The motion was seconded by Cameron McConahy and passed with all present voting yes.

Visitor Cari Rogers was present to discuss the sewage backup issue that happened on 10/29/22 at her residence on Lake Road. Mrs. Rogers submitted bills totaling approximately \$1,500.00 to be reimbursed to her for damages caused by the backup.

Visitor Todd Clary was present to present a lawn care invoice for grass seeding he had completed due to the excavator not doing so upon completion of the storm drain repair. He is requesting reimbursement for one half of the \$2,000.00 invoice amount. Attorney Rodrigues recommends calling the excavator about seeding cost.

Doug Robbins made a motion to appoint Gregg Sanford as the Emergency Management Coordinator for Clark Borough. The motion was seconded by Doug Robbins and passed with all present voting yes.

Cameron McConahy presented two flyers containing different services that his company, Zekelman Industries, has been providing different services within the Community.

Monica Simko read the Sewer bills for the month of November. Cameron McConahy made a motion to pay sewer bills as read. The motion was seconded by Joe Simko and passed with all present voting yes.
