## Minutes of the Clark Borough meeting –June 6, 2023 6:00PM

The meeting of Clark Borough Council was called to order by council President Jim Carucci who led in the pledge to the flag on Tuesday June 6, 2023 at 6:00 p.m. Others in attendance were Maryjo Harakal, Doug Robbins, Larry McKnight, Joe Simko, Alesha Culp, Attorney Tara Rodrigues, Chief Piccirillo and Monica Simko.

Doug Robbins made a motion to accept May minutes as amended. This motion was seconded by Joe Simko and passed with all present voting yes.

Jim Carucci read the Treasurer's Report for the month of May. Larry McKnight made a motion to accept the Treasurer's Report. The motion was seconded by Joe Simko and passed with all present voting yes.

Jim Carucci made a motion to try Cintas for supplies and mats. The motion was seconded by Alesha Culp and passed with all voting yes, except Doug Robbins opposed.

Council requested that Monica Simko reach out to Franklin Insurance and ask how we are to match the shingles to the rest of the roof if they are only covering one side.

Doug Robbins made a motion to make an online transfer of \$5,000.00 from the Liquid fuels savings to Liquid fuels checking to cover the bills for the remainder of the year. The motion was seconded by Jim Carucci and passed with a roll call vote of Jim Carucci – Yes, Doug Robbins - Yes, Larry McKnight - Yes, Joe Simko – Yes and Alesha Culp – Yes.

Jim Carucci made a motion to the agenda to include the email from the ATF. Doug Robbins question the intentions of the applicant as far as which class it will be; is it a federal firearms license or will there be a storefront. Council agreed that the residence at 55 McMinn Road on zoned residential and no permit is required at this time.

Monica Simko read the Sewer bills for the month of June. Jim Carucci made a motion to pay sewer bills as read. The motion was seconded by Joe Simko and passed with all present voting yes.

Joe Simko questioned the status of the sewer certificate. Council advised that it is status quo for the time being.

Larry McKnight discussed the seal coating project and requested that Jim Miller provide an update on whether the tar bucket has been reserved yet, also to get an inventory on how much tar we have left. Larry also stated that Jim Miller needs to take care of the divots in the roads prior to the sealcoating.

Maryjo Harakal read the Fire Report for the month of May. Doug Robbins made a motion to accept the Fire report as read. The motion was seconded by Joe Simko and passed with all present voting yes.

Maryjo Harakal read the Police Report for the month of April. Joe Simko made a motion to accept the report as read. The motion was seconded by Alesha Culp and passed with all present voting yes.

Maryjo Harakal asked Chief Piccirillo if he could have a patrolman be present on 258 more between 2pm and 5pm due to 2 different residents' complaints about speeding.

Alesha Culp requested to receive one paycheck per year.

Maryjo Harakal presented the Mercer County Regional Planning Commission's minutes for review.

Jim Carucci read the Payroll Distribution - General Fund Distribution and the State Liquid Fuels Distribution for the month of June. Doug Robbins made a motion to pay the bills as read. The motion was seconded by Larry McKnight and passed with all voting yes.

Jim Carucci made a motion to adjourn the meeting. The motion was seconded by Joe Simko and passed.
